Our relationship with the EPA has, in general been a good one, although we do have an ongoing issue regarding BlackBall, hopefully this will be resolved in the near future.

Finally, I would like to thank Jason for all the hard work he has put in over the years as Treasurer, I am sorry to see him stand down from the position.

I would like to thanks all the members of the EPRA support and commitment to the Association, long may it continue.

## 7. Finance Report

## 7.1 Report

### **Summary**

There was an untraceable shortfall of £1.50. The association made a net loss of £766.06 over 2012. The loss was the result of numerous factors, as: The cost of meetings incl. The Meeting Room and Refreshments, the lack of Exams carried out in 2012, the cost of travel and accommodation to EPA meeting (required attendance). Also responsible is the lack of referees in Regions 1, 6 & 8 over the cost of Regional Delegate attending meetings, referees in other regions shoring up the cost of these regions. Although not in 2012, the cost of Referees expenses for 'S' Assistant Senior upgrades is bourne by the association. It was suggested that, in order to improve the Associations finances, certain steps be taken. (i)The reinstatement of the levy on Referees Expenses i.e. £2 on Day rate and £1 on Evening rate. It should be noted that the Rates have increased from £65 to £70 & £43 to £45 respectively. (motions for Debate)

- (ii) A rise in the rate of Membership Fee (AOB Delegates Meeting 27/01/2013)
- (iii) A rise in the Exam Fee (AOB Delegates Meeting 27/01/2013)

There has not been any rises in either fee for some time.

It was also suggested that more use could be made of e-mails and that there should be a review in the method of distributing Exam results etc. material.

# 8. Examination Secretary's Report

The Total number of Candidates taking exams during 2012 was 41.

Seven E grade exams were conducted, a total of 21 candidates took part, 15 passed with a mark of 80% or better. The success rate of 71.43% is a good result, up slightly on last year. E Grade Examinations decreased from 8 down to 7, Region 6 was responsible 1 exam with 2 candidates; Region 7 held 6 exams with a total of 19 candidates

Six D grade exams were conducted; a total of 20 candidates took part 7 passed with a mark of 85% or better, a success rate of 35.00%

D Grade Examinations fell to 6 for 2012 compared to 12 for 2011. Region 2 held 1 exam with 3 candidates; Region 3 held 1 exam with 7 candidates, Region 6 held 1 exam with 2 candidates, Region 7 held 3 exams with a total of 8 candidates

Disappointingly Regions 1 4 and 5 did not hold any exams during 2012.

Two new 'A' grade promotions are to be conducted during 2013.

We currently have 3 probationary Examiners, 1 in region 2 1 in region 4 and 1 in region 7. The low level of examinations is of some concern, we rely on member subscription and exam revenue to support our association, the exam revenue for this report is only £205, probably the lowest since I took office.
