## 8. Events Reports

Intercounty Finals: 4th & 5th March 2017:

At 8:00am 10 Referee arrived to prepare the tables ready for 8:30am start of play. At 9:00am 2 further referees arrived. The morning briefing was given at 8:15am. All referees were ready for duty at 8:30am in the main arena and 9:00am in the Games Room.

All matches were best of 44 frames, in the event of a drawn match, a three frame play-off took place, these were refereed by EPRA referees. Some matches were played on three tables some on two table. The Junior matches were played on three tables in the Games Room. The day was intended to be split into two sessions, with 12 referees on each session., due to the shortage of referees, some referees agreed to work a double shift. They were under the impression that they would be paid a double shift, as is the norm, however, the TD would only pay and evening rate for the second shift. The referees concerned were obviously disgruntled. The main atrena was divided into 3 zones together with the 4 streaming tables and 1 zone in the Games Room. The 4 streaming tables, 25 – 28, were each EPRA Refereed and timed. The shifts were 60mins On & 30mins Off. The referees working a double shift were given two 45 minute breaks and worked between 75 and 95 minutes on the floor to cover this. The Senior Referee was called to the floor on three occasions, on one occasion one of the floor

The Senior Referee was called to the floor on three occasions, on one occasion one of the floor referees decisions was correct on another it was overruled. The third was disagreement between the referee and timekeeper supplied by the teams.
